RESOLUTION OF THE BOARD OF DIRECTORS

"Re: Approving the acquisition of founding shareholders' shares in a Subsidiary"

THE BOARD OF DIRECTORS PHAT DAT REAL ESTATE DEVELOPMENT CORPORATION

Pursuant to:

RESOLVED

<u>Article 1</u>: To approve Phat Dat Corporation to acquire shares from founding shareholders in Phat Dat Industrial Park Investment and Development JSC ("Phat Dat IP"); details are as follows:

- 1.1. Acquiring 31,800,000 shares at a par value 10,000VND/share, accounting for 15.9% of the charter capital of Phat Dat IP, from Mr. Nguyen Huy Le with a transaction value of 318,000,000,000 VND (three hundred and eighteen billion VND)
- 1.2. Acquiring 31,800,000 shares at a par value 10,000VND/share, accounting for 15.9% of the charter capital of Phat Dat IP, from Mr. Pham Ngoc Dung with a transaction value of 318,000,000,000 VND (three hundred and eighteen billion VND)
- 1.3. After completing the abovementioned transactions, Phat Dat Corporation will hold 199,600,000 shares, equivalent to VND 1,996,000,000 or 99.8% of Phat Dat IP's charter capital.

<u>Article 2</u>: To assign Mr. Nguyen Van Dat – Board Chairman, and Ms. Tran Thi Huong - legal representative of the Company's contributed capital at Phat Dat IP, to conduct all necessary legal procedures to acquire founding shareholders' shares in Phat Dat IP as approved by the Board of Directors of Phat Dat Corporation in this Resolution.

<u>Article 3</u>: Members of the Board of Directors, Board of Management, relevant departments/devisions of Phat Dat Real Estate Development Corporation are responsible for implementing this Resolution.
